### Description/Signalment

From 1<sup>st</sup> January 2016 under Commission Regulation EC262/2015, only passports with a completed silhouette can be issued. The silhouette should be completed to a high standard, recording all features and be verified by you the vet.

Please provide the colour of the equine, distinguishing marks, acquired marks and visible whorls.

For whole coloured horses with less than three whorls, EU legislation requires each chestnut to be drawn.

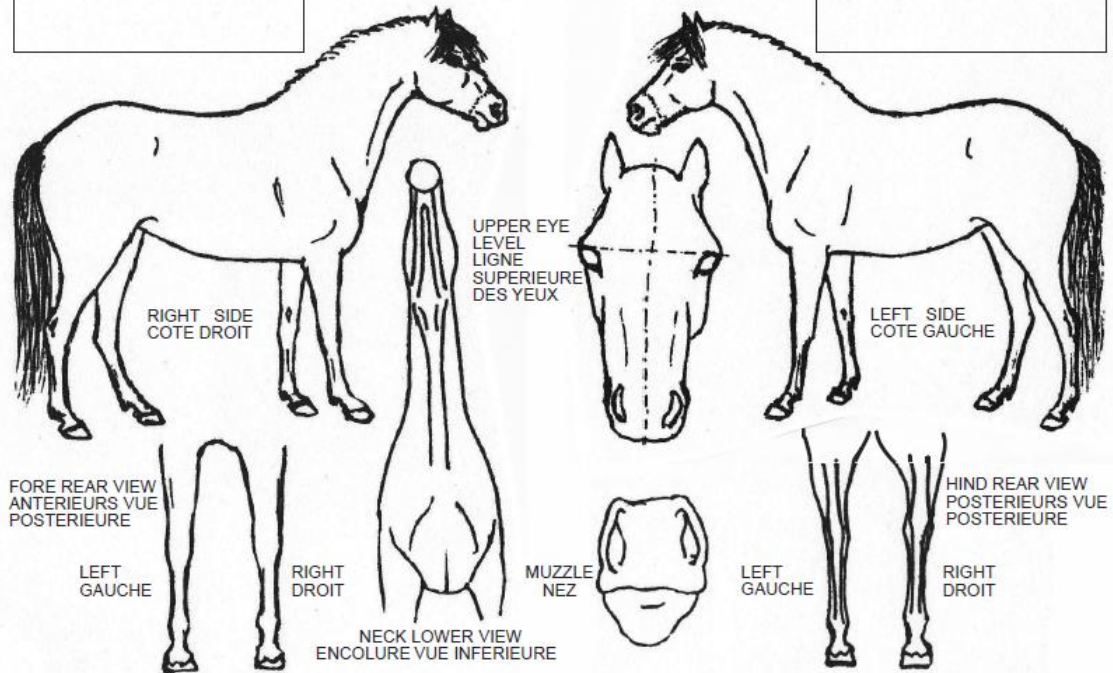
